

# EDMONTON SCREEN INDUSTRIES LOCATION REBATE PROGRAM

# PROGRAM OVERVIEW

### Mission

Driven by values of success, growth, diversity, community and passion, we are a responsive, ambitious, prudent and cooperative organization that seeks to strengthen and support Edmonton's screen industries ecosystem.

## Objective

The ESIO offers a location rebate program with funding intended for reimbursement of location fees to provide an incentive for local and guest screen media enterprises to locate their projects in the Edmonton Metro Region.

## Background

The ESIO is an independent, non-profit, arms-length society that receives operational support from the City of Edmonton and is led by an independent board of directors with a broad range of business competencies.

## **Edmonton Metropolitan Region**

Located in Northern Alberta, the ESIO's footprint is the Edmonton Metropolitan Region, which encompasses and is defined by: The Cities of Edmonton, Fort Saskatchewan, Leduc, Spruce Grove, and St. Albert, the Towns of Beaumont, Stony Plain, Devon, Morinville, the Hamlet of Sherwood Park and Leduc County, Parkland County, Sturgeon County, and Strathcona County. For the purposes of this document, the word "Edmonton" shall mean the Edmonton Metropolitan Region.

## Description

Screen media productions can apply for a rebate on actual spend of location fees including: site rentals, support areas and/or studios situated within the Edmonton Metro region, as well

as municipal costs such as permits, fire and/or police services from communities included in the Edmonton Metro region.

Successful applicants must commence the project within six months of approval, deliverables are expected to be shown to ESIO within one year of approval.

GST amounts are not eligible for the rebate program.

## Applying

Applications will be accepted a maximum of six months and a minimum of two weeks in advance of the start of principal photography.

## Reporting

Reporting obligations will be outlined in the Contributions Agreement, including but not limited to:

- List of Edmonton Metro locations accessed,
- Proof of payment for approved location fees,
- Confirmed cast and crew list identifying positions filled by Edmonton Metro residents,
- Call sheets

Applicants will be reimbursed for verifiable, eligible expenses up to the maximum amount of the approved contribution.

Reporting obligations must be met prior to disbursement of the ESIO rebate.

# ELIGIBILITY

## **Eligible Projects**

- Local screen media productions
- Guest screen media productions
- Screen media co-productions

Applicants must be incorporated and in good standing with the ESIO and the City of Edmonton.

Minimum production spend of \$10,000 in Edmonton Metro region for program eligibility.

#### **Ineligible Projects**

- Activities funded by other ESIO programs and activities for which the applicant has already received funding, or a commitment for funding, from the ESIO.
- Projects that do not have commercial potential.
- Projects that are primarily propaganda (false, exaggerated or distorted ideas, visual material and statements typically used for a political purpose)
- Projects that promote cruelty, sexual violence or sexual exploitation.
- Projects which contain elements that are pornographic, obscene, indecent or contain child pornography or are considered hate speech within the meaning of the Criminal Code of Canada.
- Projects that are libelous or in any way unlawful.

# **CRITERIA & EVALUATION**

Applications will be evaluated based on a number of factors to determine eligibility, such as:

- Economic impact for the Edmonton Metro region;
- Budget level of project;
- Applicant's track record;
- Overall program demand.

The evaluation process will be scaled to the specific needs and requirements of each application at the sole discretion of the ESIO. The ESIO may request additional documentation beyond what is specified in the initial application requirements.
